080/19 Planning

(a) Applications Received:

WP/19/00263/FUL – garage & porch to front of property & single storey extension to rear. Proposed to change vehicle access to Blackwell Close instead of Broad St – 62-66 Broad St

WP/19/00280/FUL – proposed new detached storage building together with replacement windows/dormer windows providing new guarding to front of dormer window. New glazed entrance canopy & repair & replace existing timber over windows – Grangefield Residential Home, 60 Northampton Rd

WP/19/00285/FUL – proposed demolition of conservatory & rear workshop & erection of single storey rear extension – 8 Spring Gardens

WP/19/00292/FUL - subdivision of existing dwelling to form two dwellings – the existing dwelling was originally two dwellings – 31 The Square

WP/19/00295/FUL – demolition of existing conservatory. Part single, part two storey side extension with single storey rear extension along with associated internal alterations. Extension of front canopy above garage over porch – 21 St Crispin Rd

WP/19/00306/FUL – two storey side extension with pitched roof – 20 Compton Way

WP/19/00319/OUT – application for outline planning permission with all matter reserved for construction of a detached bungalow – 132 Northampton Rd

Following discussion, it was resolved to object to application WP/19/00292/FUL due to the lack of off-street parking being in contradiction to the policies of the Neighbourhood Plan. No comment was required on the other applications received.

- (b) Proposed Use of Commercial Site, David Wilson Homes Development – it was agreed that the Clerk look further into the proposed use of the land and report back at the next meeting.
- (c) Redrow S106 Monies – it was resolved that a meeting of the Strategic Planning Committee be organised to discuss projects for the Environment and Art funds.

#### 081/19 Police/Community Safety

- (a) Crime Figures and Report – no report received.

#### 082/19 Sports and Leisure Development

- (a) Update including funding request for Pioneer Sports Field – it was resolved to suspend standing orders to allow the Chair of Earls Barton United Football Club to address the members. EBUFC requested funding for improvements to Pioneer Sports Field, to allow the FC to relocate to the Pioneer whilst work is carried out at The Grange Sports Field. Following discussion. It was agreed that £35,000 be made available from the Sports Fund to allow the necessary work to be carried out. It was also resolved to approve a quote of £1000.00 from Labosport to carry out a cricket boundary assessment at The Grange Sports Field.

#### 083/19 Institution and Induction of Revd Jenny Ingram

It was agreed that Cllrs Abbott, Morrall and Rice attend on behalf of the Parish Council.

#### 084/19 VE Day 75<sup>th</sup> Anniversary

It was agreed that the Clerk look into events to commemorate the anniversary and report back at a future meeting.

#### 085/19 Highways & Maintenance

- (a) Road Closure, High Street – it was noted that the High Street will be closed for one day on 16 June.
- (b) Recreation Field Electricity Point – it was resolved to approve a quote of £550.00 to provide electricity to the Recreation Field from the Youth Club.

#### 086/19 NCALC/SLCC/ACRE Correspondence

- (a) NALC Star Council Awards – it was noted that the Clerk has submitted an application on behalf of the Parish Council for the Soap Box Derby.
- (b) Northants CALC AGM – it was noted that the AGM will be held on 5 October. Confirmation of attendance to be agreed at a later date.

#### 087/19 Borough Council of Wellingborough

- (a) Local Government Reform in Northamptonshire – it was confirmed that the dissolution of the eight principal councils in Northamptonshire and the creation of two unitary councils has now been authorised by central government. The two unitaries will come into effect from 1 April 2021. Town and parish elections will take place in May 2020.
- (b) BCW Parish Forum – the Clerk will attend the meeting on 11 July. Cllr Morrison also to be asked if she would like to attend.
